  - Tier2=Difference between Tier1 and maximum amount of renewal and CoC Bonus Projects (does not include Planning Grants and If HUD selected a DV Bonus project during the initial DV Bonus selection, HUD will remove that project from the FY 2023 Priority Listing and move the projects below it up one rank position.)
